BYLAWS: The Council continued discussion of revisions to the Braeburn SN #30 bylaws. Updates were reviewed as outlined in the draft bylaws circulated to Delegates for

feedback. Topics discussed included clarification of boundaries, terminology for stakeholder organizations, eligibility of businesses, and attendance requirements for delegates. The question of tenant associations and the delegate removal process was tabled for further discussion at a future meeting. No final action was taken, as review and approval of revisions will follow the process outlined in the bylaws, with voting reserved for Primary Delegates.
